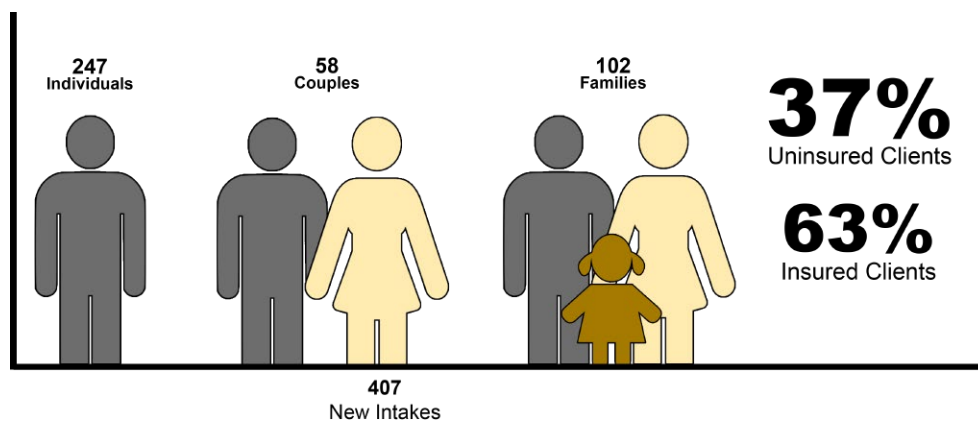

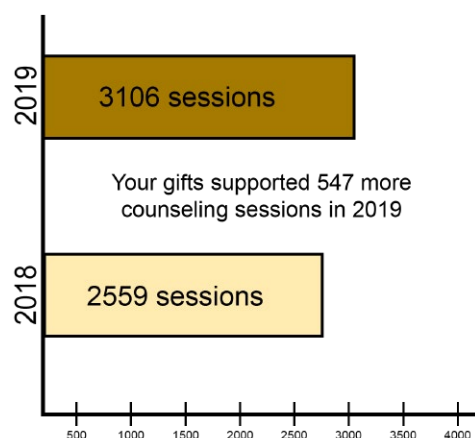

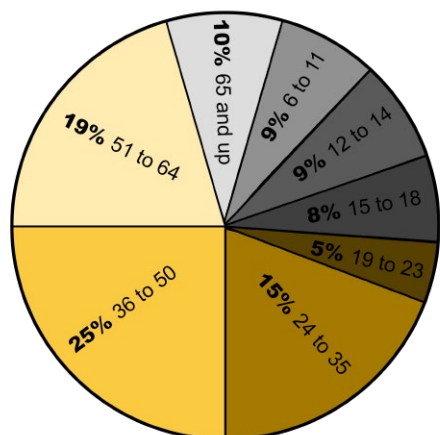

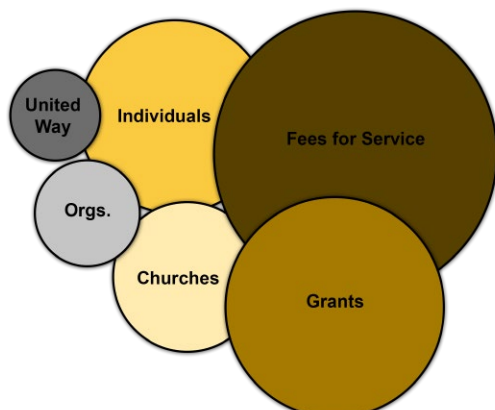
Client Demographics

Income from Contributions

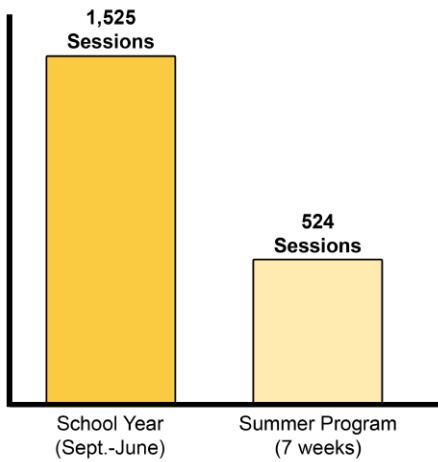

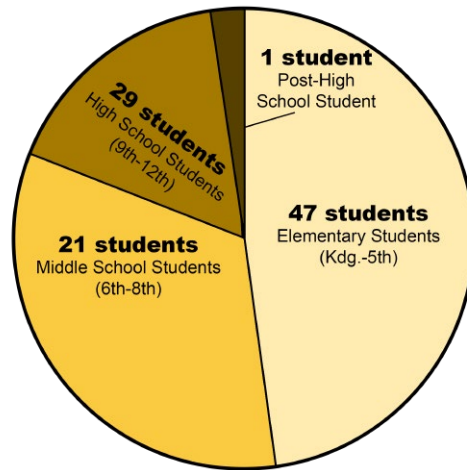

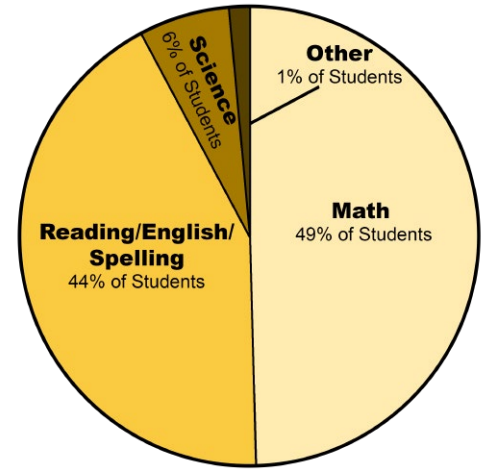
THE IMPACTS OF ANCHORPOINT TUTORING

Total sessions for 2018 were 2,123

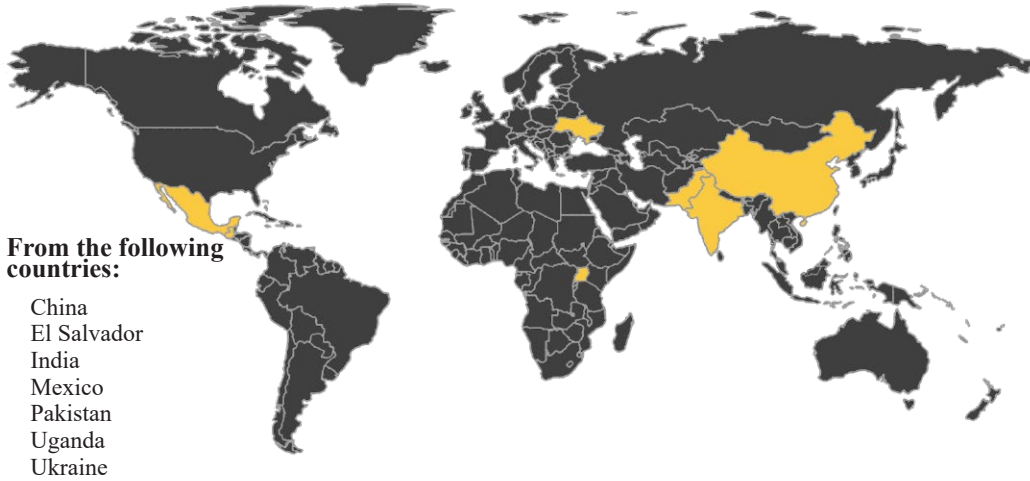


Total # of students tutored in 2019
